Senate Bill 1383 – Mandatory Organic Waste Recycling – Helping to Fight Climate Change



On September 19, 2016, Governor Jerry Brown signed Senate Bill 1383. Senate Bill 1383 established targets for methane emissions reductions by focusing primarily on the disposal of organic materials. This bill sets targets for reductions of organic materials disposed of in landfills, requires edible food recovery programs to be established by all jurisdictions, and requires enforcement and reporting on these programs to demonstrate compliance. The Senate Bill requires organic waste in California landfills to be reduced 50 percent from the 2014 level by 2020 and 75 percent by 2025. It also requires that by 2025 at least 20 percent of edible food currently

sent to landfills be recovered for human consumption. The law directs CalRecycle to adopt regulations designed to achieve these targets, reduce methane emissions and support the state's climate goals. Senate Bill 1383 is the most significant waste reduction mandate adopted in California in the last 30 years. To achieve these targets, it's essential for all organic waste generators – residents, businesses, and local, state, and federal government entities – to actively participate in the organic material collection program. The regulation takes effect on January 1, 2022. Stay tuned for additional information on the City's schedule for program implementation.

Fire Hydrant Flushing

The City will be performing fire hydrant flushing maintenance beginning in late September and concluding in late October 2021. Fire hydrant flushing is the temporary short release of water from fire hydrants. It is a controlled procedure that is vital for the general maintenance and health of the City's water distribution system. It ensures adequate water capacity and pressure is available to firefighters, residents, and businesses. It also enables staff to exercise the hydrants and improves water quality by clearing mineral deposits from the water mains.

Temporary flushing will not interrupt your water service; however, it is common to see a temporary reduction in water pressure while crews work in your vicinity. Your water pressure will return to normal once the hydrant maintenance activities have been completed.

With Fall nearing upon us, the days are getting shorter and the weather is cooling down. These are both good reasons to cut back on your outdoor watering. The following tips will help your landscape stay healthy while helping you \$ave water:

- 1. Set your controller to water late at night or early in the morning (the latter is preferred).
- 2. Set your controller to water about 8 minutes per station for pop up sprinkler, and 15 to 20 minutes for drip irrigation depending on the type of drip system and the plants being watered.
- 3. Do not allow sprinkler water run off to flow onto the street or sidewalk.
